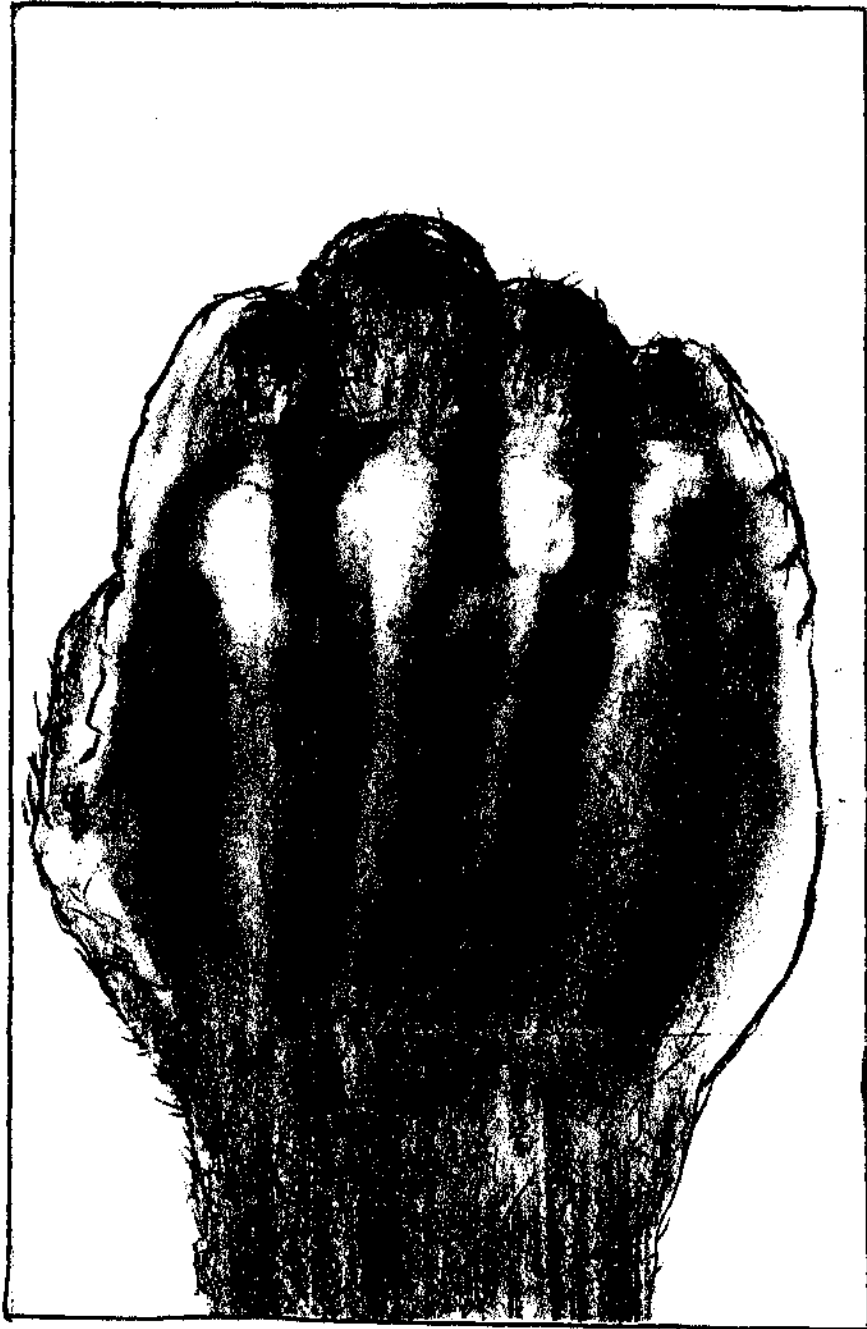

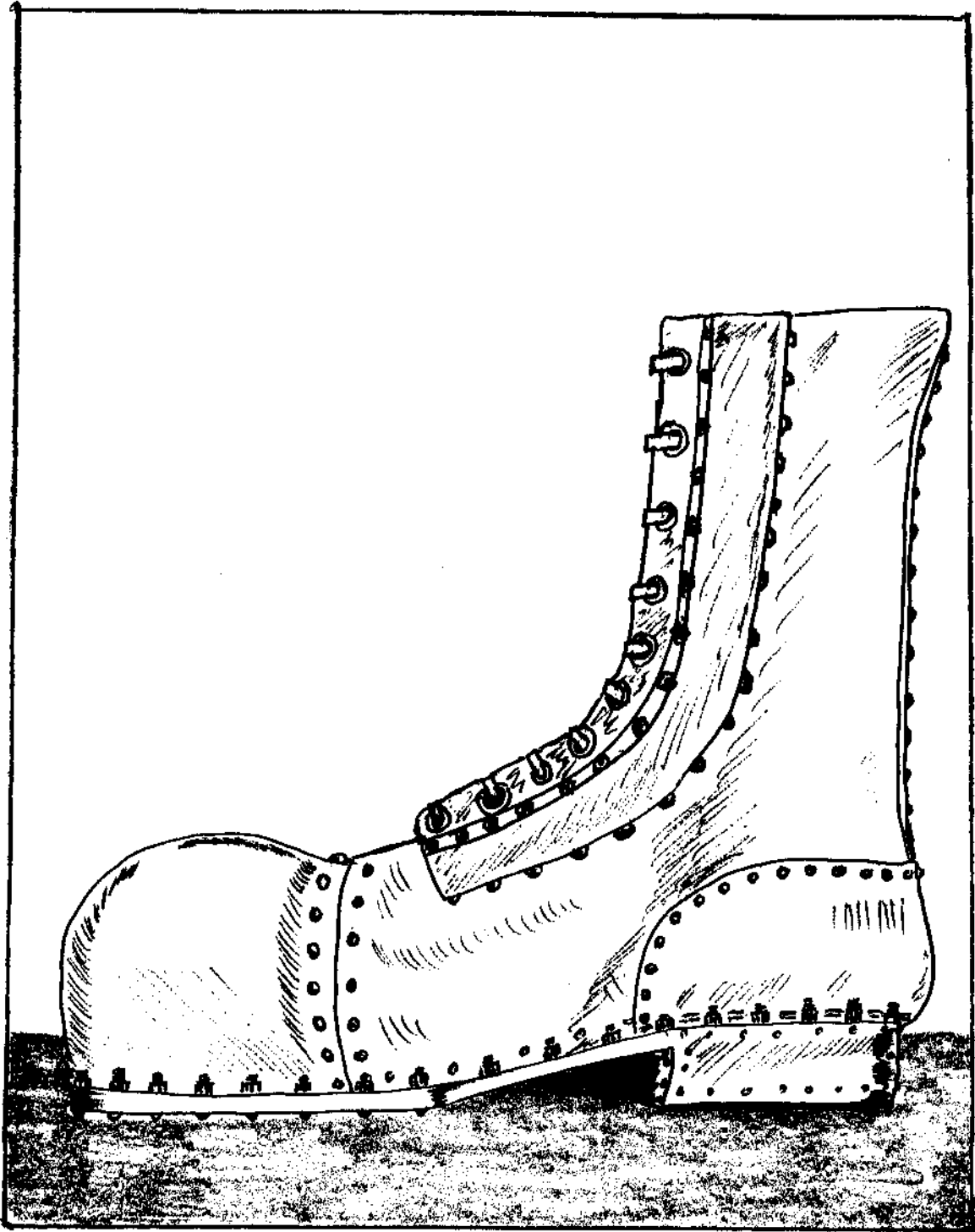

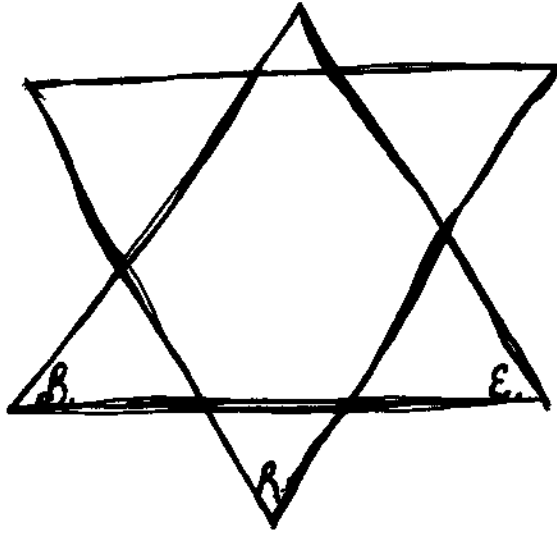

NO BREACH OF SECURITY HAS BEEN PROVEN NOR ANY REPORT OF ACTUAL INJURY AND THUS, WITHOUT ANY ACTUAL DAMAGES TO BE ASSESSED, THESE ALLEGATIONS ARE VOID. THE ADMINISTRATIVE EMPLOYEE DISCIPLINARY PROCEDURE IS NOT MEANT FOR PURPOSES OF VEXATION AND HARASSMENT OF EMPLOYEES, AND ACCORDING TO FEDERAL LAW, AND TITLE VII OF THE CIVIL RIGHTS ACT, RELIGIOUS EMPLOYMENT DISCRIMINATION IS PROHIBITED, I.E.

ANY ACTION(S) TAKEN AGAINST THE ACCUSED HEREIN, FOR, IS AN ABUSE OF THE ADMINISTRATION'S POWER(S) IN THE EMPLOYEE DISCIPLINARY PROCEDURE AND IS INDEED, FURTHER A VIOLATION OF THE ACCUSED RELIGIOUS BELIEF(S).
