Detective Mandy Cooper(stepped in the room and interupted the conversation) Detective Menrilly can I speak with you in the hall It will only take a min

Kevin (standing next to his 2 other friends Tone and Punch) they had me at the station like I did somthing asking why where we on that street I told dude because this a free country, then I told the Detective everything that happened, I swear we wont on nothing.

Ms. Fletcher (sitting next to Mr. George on the couch) he took my baby

Mr. George (looking at Ms. Fletcher) he will not get away with hhis I promise and the chief of police will speak on CNN in about 5 min. Just off kevins statment the officer should get indicted but we know how they look out for each other

Kevin (talking to :Tone and Punch) man look whatever happens we gotta stay strong and be here for Ms. Fletcher that's what lil ron would wont

Tone (standing Ice grilling Kevin) man fuck all that if they let blood go tearing this bitch up, it an't gon be no killing without no killing. I'm tired of losing homies, the police that killed my girl brother last year walked, Im 17 and never met my father because the police killed him, like when is this gonna stop. When we kill they call it murder while locking us in a cell forever, police kill they say he's doing his job then he's moved to another district or city, shorty I'm fed up

Punch (shaking his head in agreement) shorty I feel you

Mr. George' (pointing towards the TV screen) he' about to speak

I know this has been a tragic time for the Fletcher family and for the city of Chicago. The CPD sends our condolences to the family and trust me we will seek justice. This is a process that takes steps, we got investigators as well as the state attorneys office handling the case as we speak now for our peaceful protesters we don't want to violate anyone's constitutional rights meaning we are with all the peaceful protesting but we will not tolerate any riots or criminal activity. THAT'S WHEN THE MUSIC STARTS TO FADE AWAY GOING INTO SCENE 4.

Scene 4

Ms.Fletcher living room the family about to receive life changing information

Tone(walking off stage)shorty we about to gangbang with these people

Kevin(trying to stop tone and punch)
come on ya'll lets think about this that's what they wont, we need to let Mr.George do his job that's what we paying him for.

Tone(stopped now ice grilling kevin)
fuck that and you need to pull your fucking skirt down and man up it's us against them out here, just stay out my way homie

Mr.George(consoling Ms.Fletcher) This still is a process, this is far from over they forgot we still got devin statment he's the main witness on this so it's far from over we just gotta keep fighting,the case is not closed now they are opening doors for a nice lawsuit Ms.Fletcher, I promise they will not get away with this, I'm gonna give this my all because I'm tired of the police thinking they are bigger than the law these type of cases been getting over looked far to long.

DAVIDED AND TAMEKA ARRIVE TO DELIEVER LIFE CHANGING INFORMATION TO MS.FLETCHIER AND THE FAMILY.
